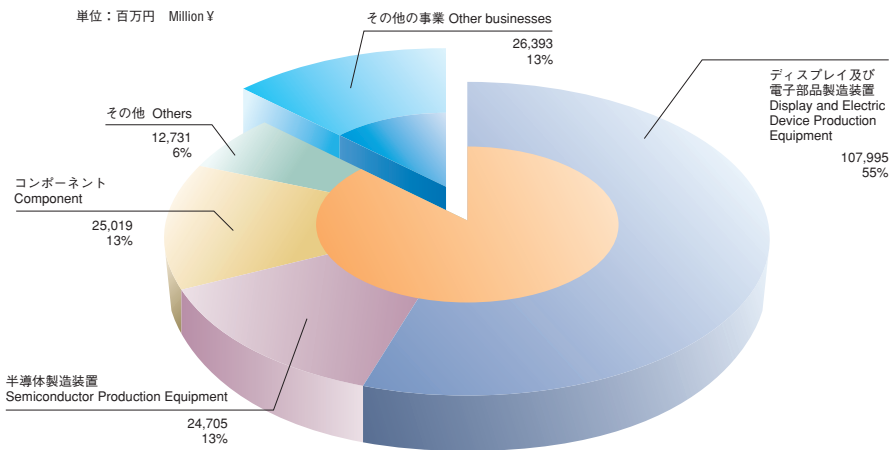

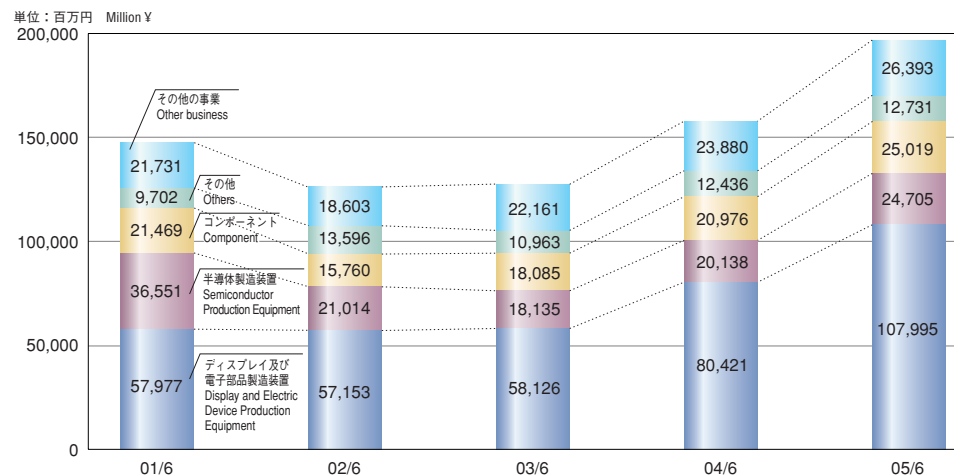

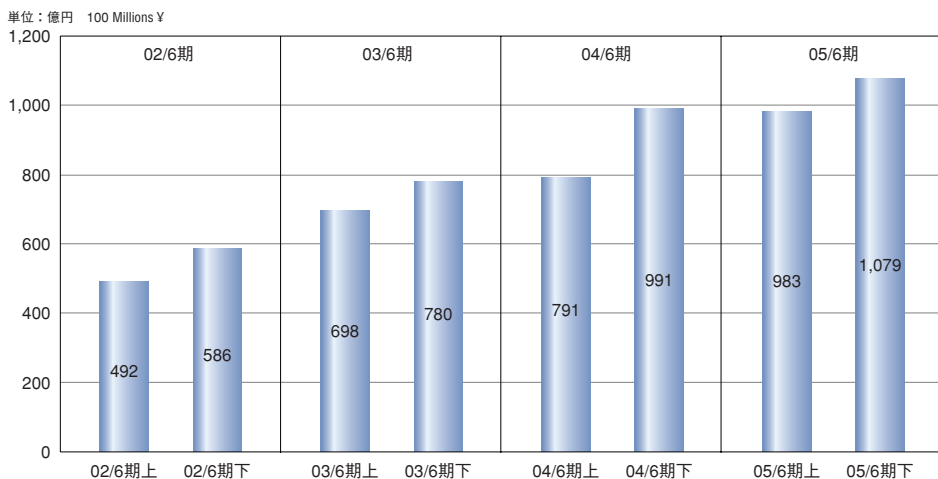
2005年6月期連結売上高構成比 (品目別)
Consolidated-sales percentage in 2005 (Segment)



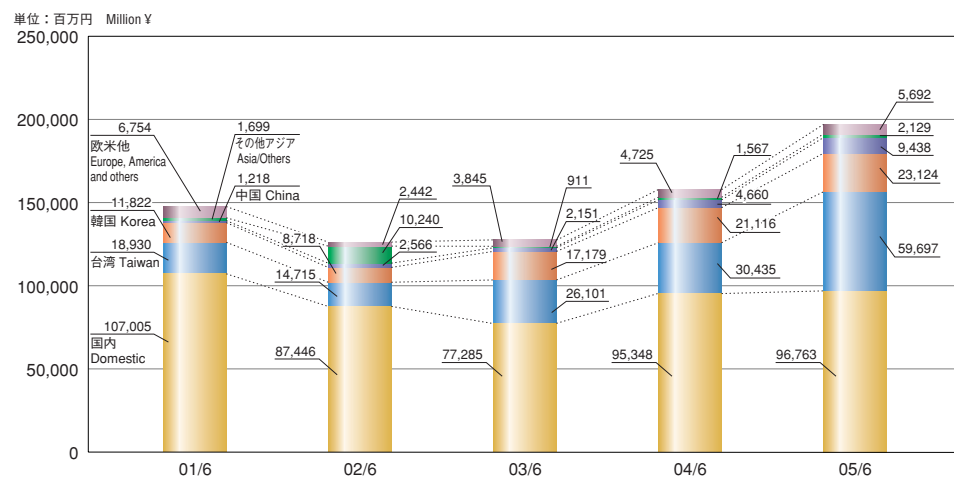
連結売上高推移 (品目別)
Transition of consolidated-sales (Segment)



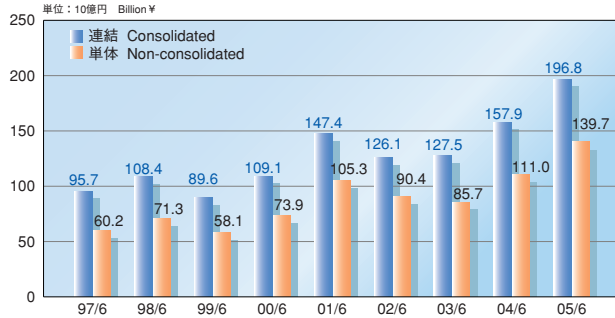
連結受注高推移
Transition of orders received



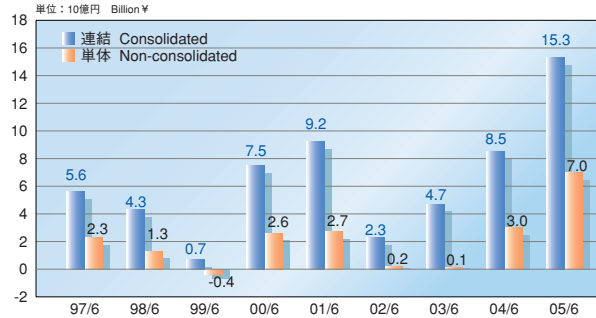
連結売上高推移 (地域別)
Transition of consolidated-sales (Region)



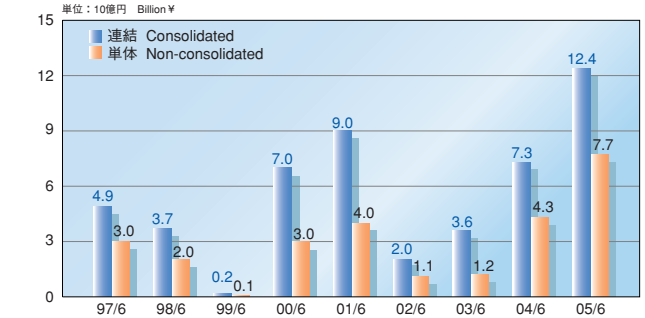

Gross profit to net sales



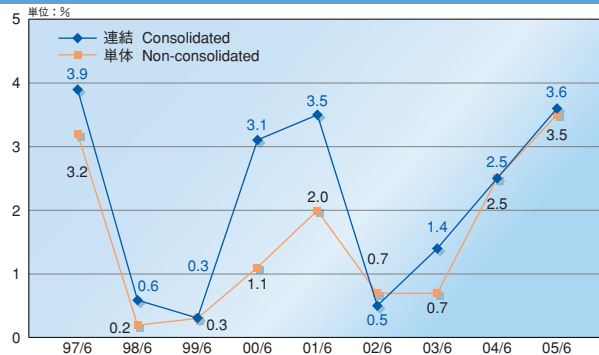
売上営業利益率
Operating profit to net sales



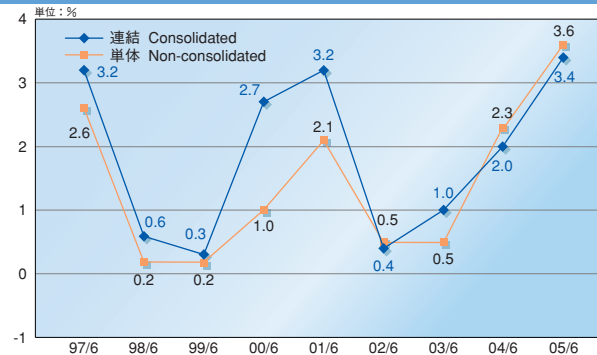

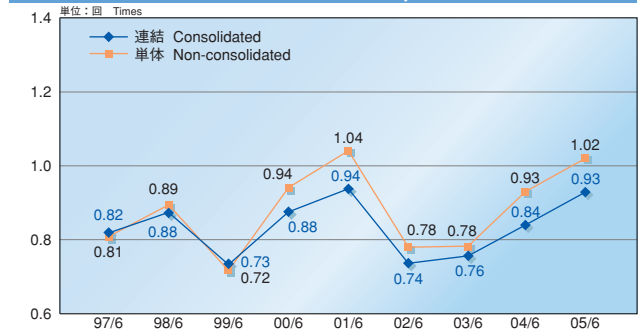

Ordinary profit per one employee



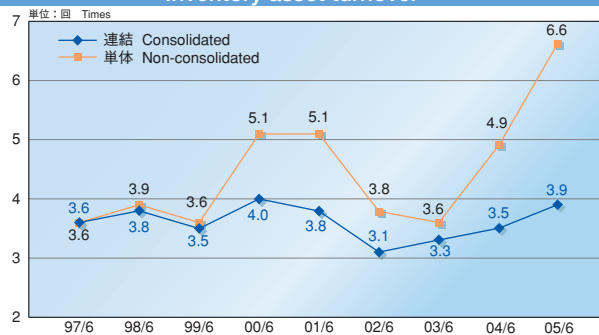

Turnover of total capital



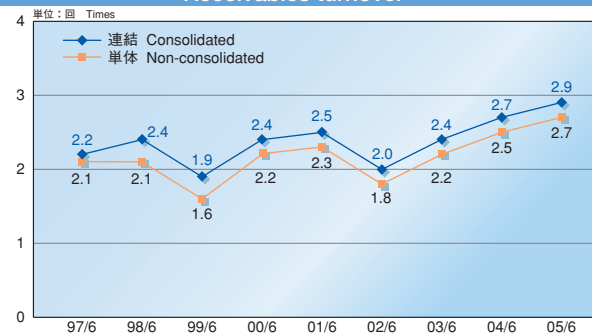

Inventory asset turnover



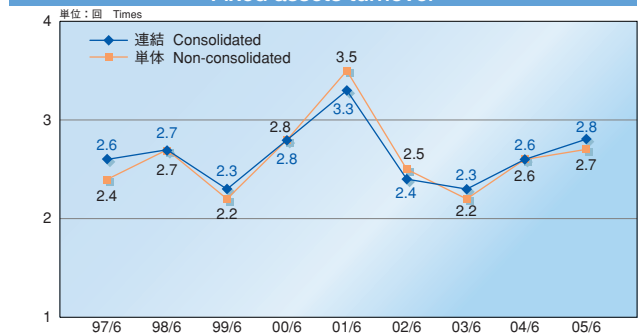
