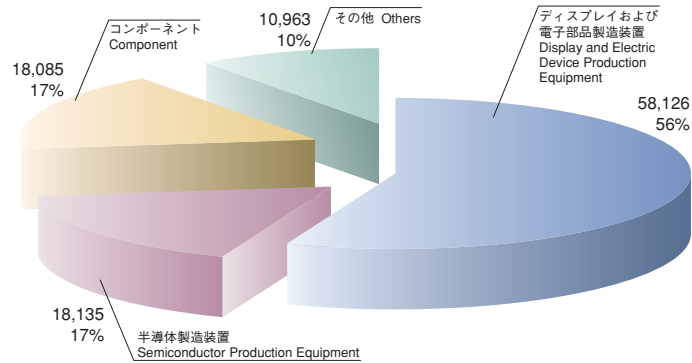

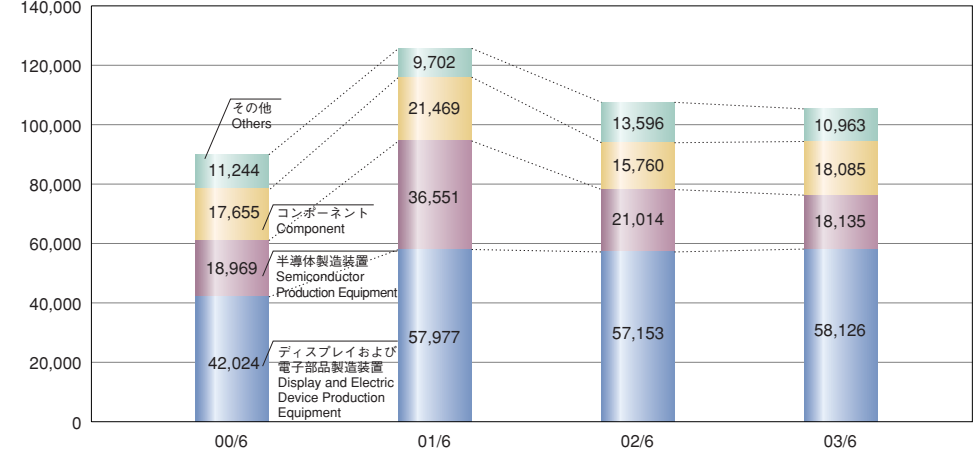

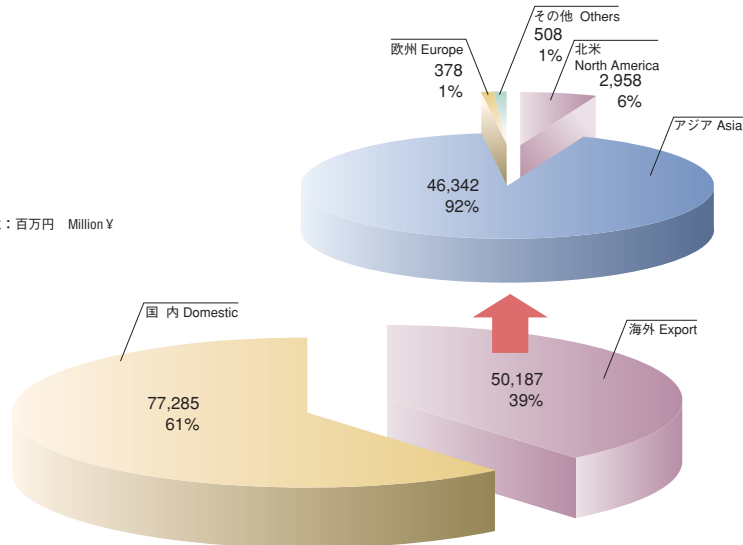
連結売上高推移（品目別）

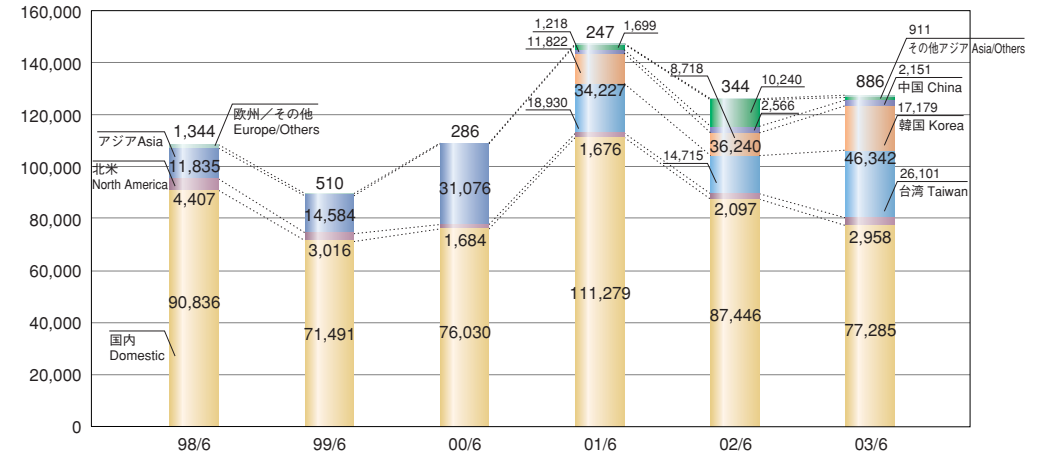
2003年6月期連結売上高構成比（地域別）

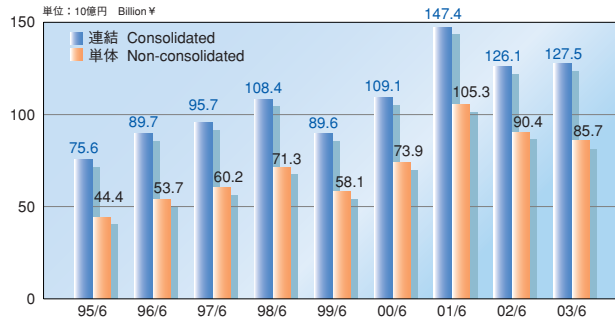


連結売上高推移（地域別）
Transition of Consolidated-sales (Region)

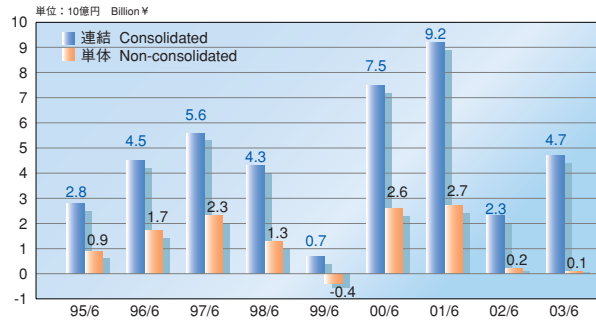

Gross profit to net sales



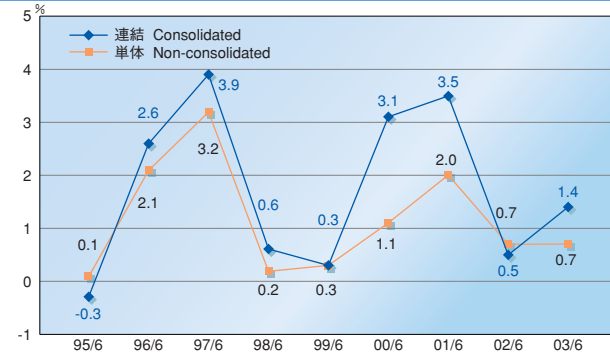
売上営業利益率
Operating income to net sales



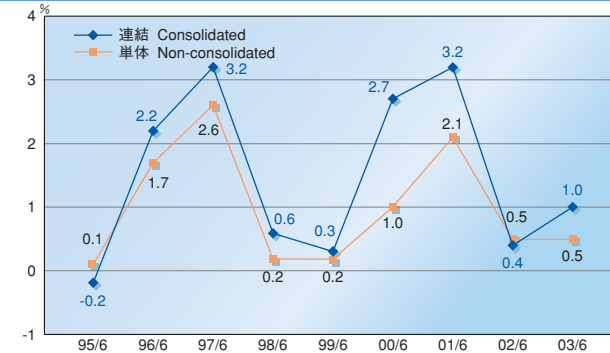
